CHILD MEMBERS WAIVER

Children under the age of fourteen (14) years may be admitted by the Committee as Child Members provided that:

- a) they belong to an academy, coaching clinic or other approved sporting development programme operated by the Club.
- b) their application is proposed by two (2) members of the Club and signed by the applicant's parent or guardian who must be known personally by at least one of the sponsors.
- c) they continue to take an active part in the academy or other approved sporting development programme.
- d) they shall not be eligible to enter the Pavilion and shall be restricted to those areas as they may be required to attend.
- e) they shall be subject to the Rules of the Club.

The entrance fee payable shall be such sum as the Committee shall from time to time decide. It shall be necessary for the relevant sports section to seek membership for the child as a Junior Member on attaining the age of fourteen (14).

- a) In recognition of the possibility of physical injury, I voluntarily accept and assume this risk on behalf of my child______ as part of his/her playing at or for the Queen's Park Cricket Club (QPCC).
- b) On behalf of my child______I hereby release, discharge and otherwise indemnify the Queen's Park Cricket Club (QPCC), from any liability for injuries which may arise as a result of his/her participation at or on behalf of QPCC.
