PLAYING MEMBERS

"Any person who having been recommended by the relevant sporting Sub-Committee and who is over the age of eighteen (18) years and in the opinion of the Committee has sufficient ability in the particular sport may be admitted to membership on the following conditions:-

- 1) He/She shall give an undertaking in writing that he/she would represent the Club for a period of not less than five (5) years.
- The entrance fee payable on being accepted is such sum as the Committee shall from time to time decide.
- 3) He/She shall be subject to expulsion in accordance with Rule 31(1)"

WHEREAS the Queen's Park Cricket Club has agreed to provide medical insurance coverage of up to Twelve Thousand Dollars (\$12,000.00) to players who represent the Club:-

- a) I recognize the possibility of physical injury and voluntarily accept and assume this risk as part of my playing for the Queen's Park Cricket Club (QPCC).
- b) I hereby release, discharge and otherwise indemnify the Queen's Park Cricket Club (QPCC), from any liability for injuries which may arise as a result of my participation on behalf of QPCC, in excess of the medical insurance coverage of Twelve Thousand Dollars (\$12,000).
